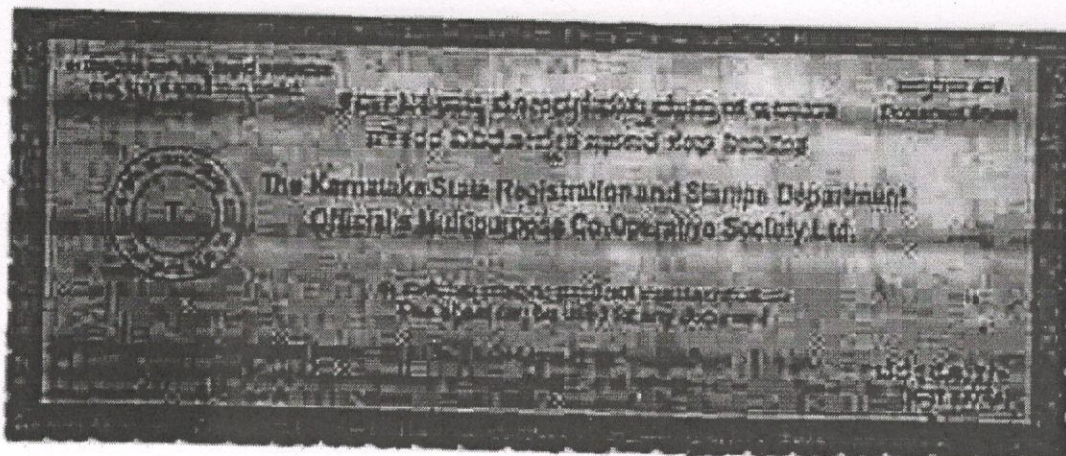

1. **NAME OF THE TRUST:** The name of the Trust shall be New Horizon Educational & Research Trust.
2. **OFFICE:** The Office of the Trust shall be at 140, Ganapathi Nivas, 4th Main, Defence Colony, Bangalore - 560038.
3. **OBJECTS:** The Objects of the Trust shall be:

To promote, assist and / or maintain all activities of whatsoever nature carried on in furtherance of the objects of the Trust and which are in the opinion of the Trustees.

- a. To establish, support, maintain or grant aid to University / Universities of Education sector, Hospitals, Schools and Colleges, Senior Citizen Homes, Orphanage Homes and such other Institutions or Societies for Public benefit as the Trustees may think fit and proper for the purposes of relief or aid to poor, needy and deserving persons.
- b. To grant relief on the occasion of earthquakes, floods, famines and other occasions of calamities and general distress and to give donations to other institutions doing similar activities.
- c. To establish, maintain and support homes for poor or needy widows, destitute, orphans, senior citizens or otherwise to support them or establish yoga center and to do all acts, deeds, and things for their relief and uplift.

4. **BENEFITS OF THE TRUST:** The benefits of the Trust shall be open to all public irrespective of Caste, Colour, Sex, Creed or Religion.
5. **TRUST PROPERTY:** The Trust property shall consist of the Initial Trust Fund contributed by the Authors of the Trust (Founders) this day and all other amounts, securities, properties movable and immovable which may be contributed by the Founders, others Trustees and the Business Community / other Institutions/ Foundations/ other Trust and the General Public.
6. **BOARD OF TRUSTEES:** The Trust shall be managed by the Board of Trustees consisting of Author (Founders) Trustees and Life Trustees as appointed by the Founder Trustees / Board of Trustees from time to time.
  - a. **Founder Trustees (OR) Life Trustees:** The Authors of the Trust and any Person appointed by the Authors/ Founder Trustees/ Board of Trustees shall be called Life Trustees and shall hold office for a period of Life or until they voluntarily resign or declared as insolvent, insane or suffers from any incapacity or death. And such Life Trustees shall have all the absolute powers as vested with the Author/ Founder Trustees.
  - b. **Co-opted Trustees:** The Authors / The Board of Trustees shall co-opt any person/persons who will be useful to the Trust.

The term of Office of such co-opted trustees shall be such period as board of trustees decides from time to time or he/she voluntarily

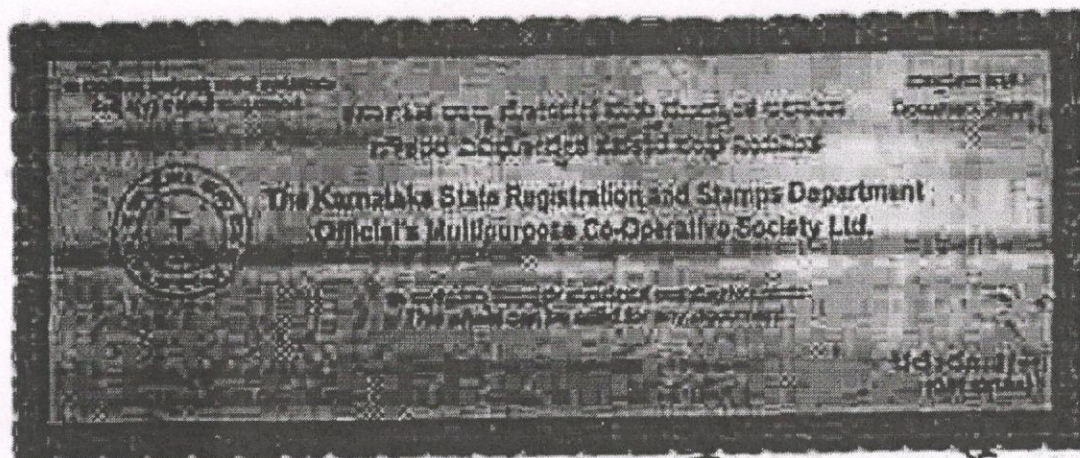

- c. Any vacancy caused due to or arising out of resignation, death, insanity, retirement, abandonment or sentenced in a Court of Law for moral turpitude, then the Trustee concerned shall automatically lose his/ her trusteeship and in his/her place, the Board of Trustees shall nominate an individual as Life Trustee/ co opted Trustee

7. **OFFICE OF TRUST:** The Board of Trustees shall elect Managing Trustee among the Founder / Life Trustees.

8. **RIGHTS AND DUTIES OF THE TRUSTEES:** The Board of Trustees shall have power and authority to administer the Trust and its properties and funds and to do all acts, deeds and things to promote the objects of the Trust. The Trustees shall have power and authority for the purpose of this Trust:

- a. To administer, supervise and manage the trust and all its affairs, activities, properties and institutions.
- b. To take all policy decisions pertaining to the Trust.
- c. To acquire properties both moveable and immoveable and to sell, alienate, transfer, handover management, mortgage, buy, acquire, take or give on lease, or otherwise deal with them as the Trustees may decide, and to vary all investments from time to time.
- d. To constitute such Committees, Managing Committees or Governing Councils for varying on any of the activities of the Trust and entrust

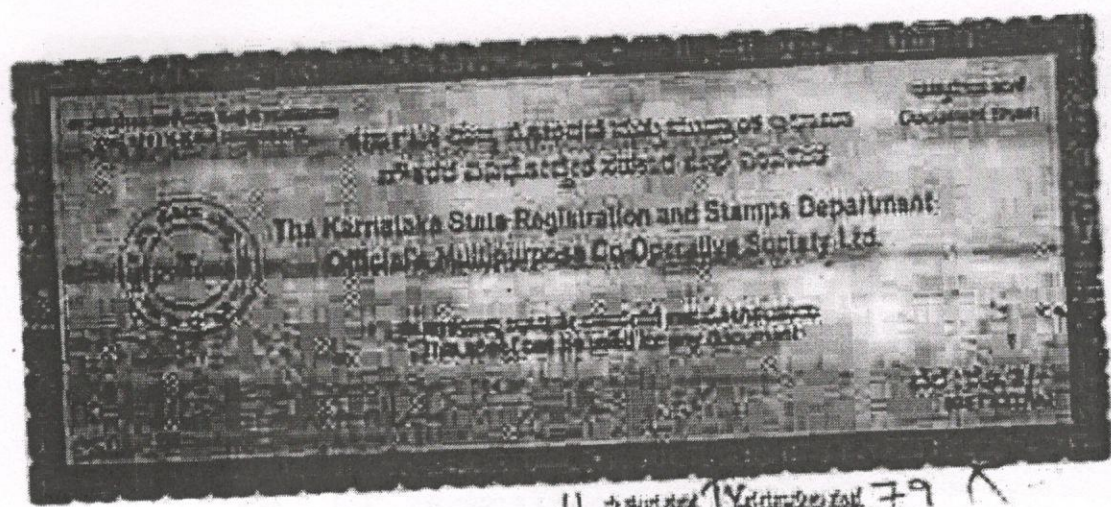

- to these committees / councils such powers as may be decided by the Council of Trustees, from time to time which are not binding on the Board of Trustees/ Managing Trustee. The decisions of the sub committees are only recommendatory in nature.
- e. However, all such committees / councils shall function on the overall supervision and control of the Managing Trustee who shall also have the powers to issue directions from time to time to such committees/ councils for their proper functioning.
  - f. To invest the funds of the Trust in the modes prescribed under the provisions of the Section-13 (1) (d) read with Section 11(5) of the Income Tax Act, 1961.
  - g. To purchase/sell, mortgage, lease, hire or otherwise alienate the properties of the Trust.
  - h. To borrow moneys with or without security and to repay the same.
  - i. To enter into contracts, vary and rescind them.
  - j. To open Bank Accounts / avail term loans/ other loans from banks/ institutions / overdraft accounts and provide for operation thereon from time to time.
  - k. To receive gifts, grants, endowments and donations in cash or kind of both movable and immovable in nature.
  - l. To institute, prosecute and defend all suits legal and other proceedings.
  - m. To appear and act before Courts, Tribunals, Governmental Tax and other public authorities.
  - n. To appoint, terminate, dismiss, suspend and otherwise deal with the employees of the Trust and its Institutions.

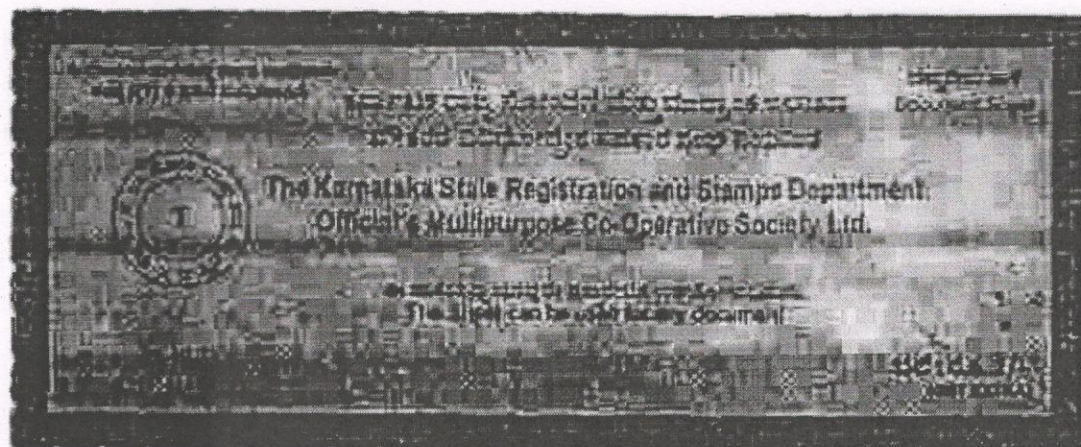



- a. To apply the properties and funds of the Trust for all or any of the objects for which the Trust is established, as may be determined by the Trustees from time to time.
  - p. To decide, from time to time, the activities and projects to be undertaken for fulfilling the objects of the Trust.
  - q. To frame rules and byelaws for the Management of the Trust, its properties and proceedings and to amend or rescind them, from time, subject to Clause (14) below.
  - r. To incur all necessary expenses connected with the Trust.
  - s. The Managing Trustee is authorized to execute any document with or without Registration including amendments to the Trust Deed or any Trustee authorized by the Board of Trustees for executing any such deed of amendments/ execute any documents on behalf of the Trust. The Board shall delegate all or any specific powers to the Managing Trustee to administer day to day affairs of the Trust.


#### 9. RIGHTS AND DUTIES OF Managing Trustee

- a. The Managing Trustee shall be in charge of the day to day affairs, activities and functions of the Trust.
- b. To preside over all the meetings of the Board of Trustees of the Trust.
- c. To call for the Meetings of Board of Trustees.
- d. To have supervision and control over Trust funds.
- e. To open and operate Bank Accounts including to overdraw such accounts / avail term loan and other facilities from the bank/ institutions.
- f. To exercise casting votes in case of a tie in any matter in the meetings of Board of Trustees.

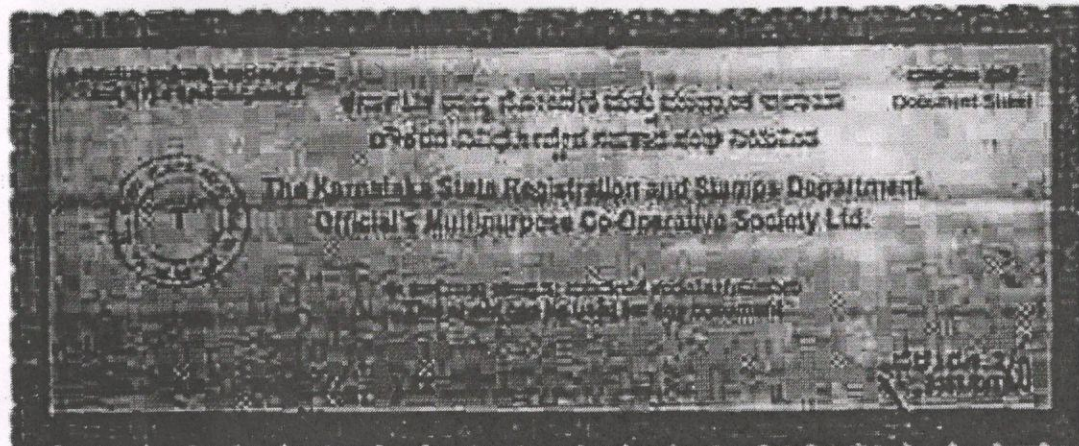

10. **TRANSACTION OF BUSINESS BY THE TRUSTEES:** The Board of Trustees may meet as often as may be necessary for the conduct of the business of the Trust. However, there should be at least one meeting every quarter.

All decisions of the Board of Trustees may be taken by a simple majority.


The Managing Trustee shall be entitled to a casting vote on the event of equality of votes at a meeting.

At least three days notice shall be given for every meeting of the Board of Trustees, provided, however, that the Managing Trustee shall have power to convene a meeting at shorter notice for transacting any business considered by him to be urgent.

The Business of the Trust may also be transacted by Circulation of papers or through E mode.


11. **DELEGATION:** The Board of Trustees/ Managing Trustee may from time to time, delegate to one or more of their powers to Governing council / Principal of the Institutions/ Chief Executive Officer/ Chief Operating Officer/ Chief Administration Officer or other Trustees of the Trust, or any other person/s or committee/s, such of their powers and duties as they deem fit subject to retaining the ultimate control and supervision by the Board of Trustees.

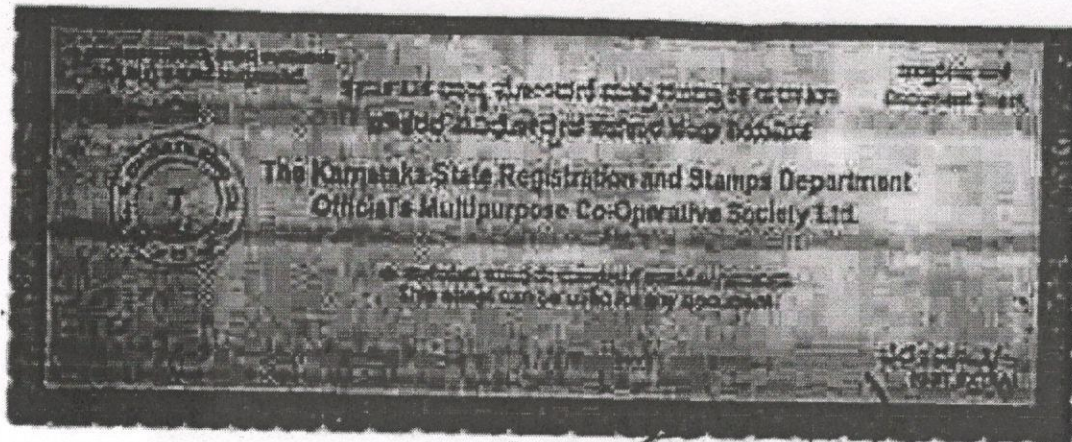

12. **Audit & ACCOUNTS:** The Trustees shall duly maintain true and correct Accounts of all Assets, Liabilities, Receipts and Expenses of the Trust and a correct record of the meetings and deliberations.

The year of account of the Trust shall be the first of April to the 31<sup>st</sup> of March every Year. The Board of Trustees shall get the accounts of the Trust duly audited every year by a Chartered Accountants/ Firm of Chartered Accountants.

13. **INDEMNITY:** The Trustees shall be kept indemnified against any action or proceeding, cost or claim, demand or liability, for anything done by them in good faith, pursuant to the power and authority vested in them under this deed.

14. **AMENDMENT TO THE TRUST:** The Board of Trustees have powers to make amendments to the Trust deed. However No Amendments to this Trust Deed or any rules and regulations framed by the Trustee, shall be made which may prove to be repugnant to the provisions of section 2(15), 11 to 13 and 80G of the Income Tax Act, 1961, subject to the above, the Trustees may amend the provisions of the Trust Deed. However, no amendments shall be made to the Trust deed without the prior approval of the Commissioner of Income Tax/ Director of Income Tax

15. **IRREVOCABLE:** The Trust formed shall be IRREVOCABLE.

16. **DISSOLUTION OF THE TRUST:** In the event of dissolution or winding up of the Trust, the Assets remaining as on the date of dissolution shall

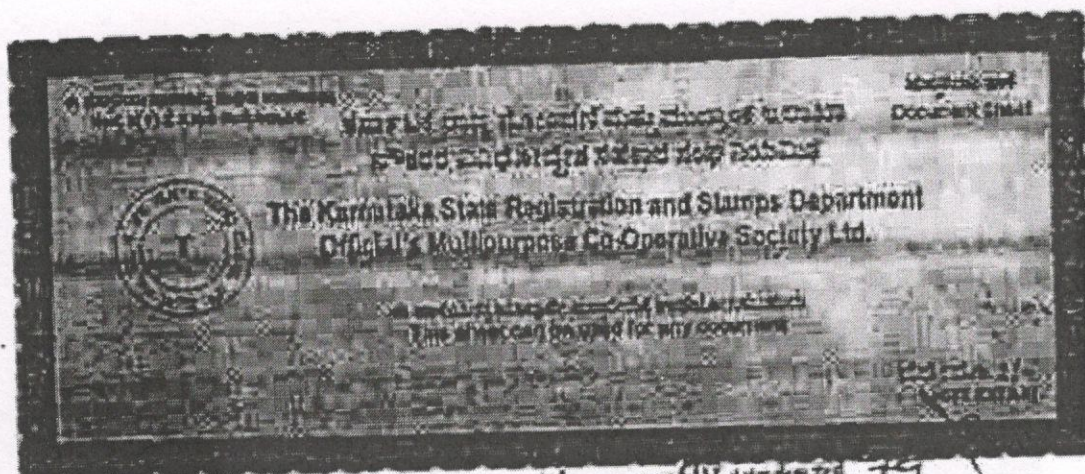
